Policy on Affordable and Clean Energy

The purpose of this **policy** is to manage energy and utility consumption across campus by implementing sustainable practices and procedures.

Sri Sairam Engineering College recognises that as a major user of energy, it has an important role to play in helping to tackle climate change by significantly reducing its CO2 emissions. We are committed to responsible energy management and the highest standards in energy efficiency. It is in the Institution's best interest to reduce the amount of money it spends on energy, releasing funds for other purposes. At the same time, reducing energy consumption helps the Institution to reduce its environmental impact.

The Energy Management Policy aims to:

- Increase awareness of energy issues and encourage all members of the Institution and adopted 5 villages to help reduce energy consumption from stakeholders
- Use of different opportunities and measures for reducing energy consumption in buildings without sacrificing comfort levels.
- Reduce fuel consumption through the introduction of energy-efficient measures;
- Identify if a building's energy performance is good, average or poor with respect to other buildings which is audited by the Institute ESSPG and EE&F members.
- Improvement of minimum 4% in total energy from the Institute Solar, Bio-Gas, Wind, etc.,
