

## SCHOLARSHIP AGREEMENT

This Scholarship Agreement (hereinafter the "Agreement") is entered into on 12th February 2023 (hereinafter the "Effective Date") at **Bangalore**.

### By and Between

**Sarojini Damodaran Foundation**, a charitable trust, having its offices at **No:383,42 cross,9th Main,5th Block,Jayanagar,Bangalore** (hereinafter referred to as "SDF" which term shall include its successors and permitted assigns)

### And

**Rakesh V, S/o Venugopal P**, aged about 17 years residing at **No.3a, karpagavalli street, ashok nagar, Kovilpathagai, avadi, Chennai, Tiruvallur, Tamil Nadu-600062** represented by **his** parent/guardian **Venugopal P** residing at **No.3, krishnappa street, ashok nagar, Kovilpathagai, avadi, Chennai, Tiruvallur, Tamil Nadu-600062** (hereinafter referred to as the "Scholar")

### Background

- a. SDF has been providing scholarships to deserving, economically underprivileged students who have completed tenth grade with excellent academic credentials. The students who have scored high marks in their tenth grade are selected through a rigorous interview and test process. They are supported through scholarships till they complete their graduation in their selected field of study, as long as they continue to excel in their studies.
- b. While SDF will continue to provide scholarships, it has developed a platform to help other Sponsors who may be willing to award scholarships for the students. This will enable more students to benefit from the program. The platform enables direct transfer of money from sponsor to the scholar to ensure complete transparency.
- c. SDF will continue to identify and select students eligible for students and will decide to make available certain number of students, for external sponsorship through the platform. The student will continue to be supported by the scholarship till completion of graduation program either through SDF or SDF approved external scholarship as long as they continue to perform well and meet the performance criteria set by SDF.
- d. Based on the Scholar's academic record and documents submitted, SDF has decided to provide the Scholar with a scholarship on the following terms and conditions.

### 1. Scholarship Terms

- a. Based on the Scholar's application and documentation shared/uploaded, SDF has agreed to provide the Scholar with a scholarship as detailed under Annexure 1 (hereinafter the "**Scholarship**").
- b. The Scholarship amount will be remitted to the Scholar at definite milestones as captured under Annexure 1 of this Agreement. . All such payments will be made by SDF or the sponsor directly via a cheque made out to the Scholar or a direct bank transfer. The Scholar will need to provide SDF with complete bank details once their application has been approved. Payments shall not be made in the name of any other person except the Scholar.
- c. The Scholar must use the Scholarship provided by SDF, solely for the pursuance of their education. The Scholarship money may be used towards the payment of school fees, purchase of books, uniform and all other activities directly associated with the Scholar's education. SDF

- reserves the right to request the Scholar at any time, to produce bills and other receipts to illustrate how the Scholarship funds have been utilised by the Scholar. Upon such a request the Scholar shall produce all such bills and receipts within seven (7) working days.
- d. For the duration of the Scholarship the Scholar must not engage in any employment without the prior approval of SDF.
  - e. SDF may at any time during the Scholarship period request the Scholar to produce/upload reports of their progress, mark lists, admission letter and other grades of their performance during the academic year. All such information must be shared within seven (7) working days and must be up to date. SDF shall have the right to evaluate the Scholar's progress and determine whether the Scholar is deserving of the Scholarship. If the Scholar's performance has reduced, as determined by SDF in its sole discretion, SDF shall have the right to re-evaluate the Scholarship grant. However, SDF may at its discretion provide the Scholar with a grace period to improve their performance, after which SDF shall re-evaluate the Scholar.
  - f. The Scholar shall at all times comply with the terms and conditions of this Agreement and any additional SDF terms and conditions and/or code of ethics made available by SDF from time to time.
  - g. The Scholar understands and acknowledges that the Scholarship is offered by SDF on a purely discretionary basis and the Scholar cannot at any time request for or avail of a Scholarship as a matter of right.

## 2. Scholar Obligations

- a. The Scholar shall ensure that all documentation shared with SDF is true, up to date and accurate. If there are any changes to the Scholar's information, the Scholar shall make the necessary modifications on the portal and/or provide such updated information to SDF.
- b. The Scholar shall ensure that the Scholar registers for the course/program at the beginning of the academic year.
- c. The Scholar shall ensure attendance to the course/program he/she has registered for and shall not absent himself/herself in excess of the permitted limit without a valid reason.
- d. The Scholar shall at all times maintain his/her grades and shall not fall below the limit prescribed under this Agreement.
- e. The Scholar shall complete the course/program he/she has enrolled for.
- f. All the Scholarship funding or benefits received by the Scholar hereunder shall only be used in the furtherance of the Scholar's own education.
- g. The Scholar shall not make any additional fund requests directly to the sponsor. The Scholar may make such a request formally to SDF. SDF may in its sole discretion offer/arrange for additional funds to be provided to the Scholar.
- h. The Scholar shall participate in any mentoring programs arranged by SDF. All such mentoring will be conducted either via email or the telephone.
- i. The Scholar will not meet any sponsors or mentors, who are part of the SDF program without the prior permission of SDF.
- j. The Scholar shall participate in any induction, developmental and/or trainings programs conducted and/or scheduled by SDF.
- k. The Scholar hereby grants SDF the right to publicise the Scholar's general information on the SDF Website, SDF social media campaigns/posts, brochures and other SDF promotional events. Upon SDF's request the Scholar shall share his/her experiences, in person or in writing, while he/she was a beneficiary of the SDF scholarship.
- l. The Scholar shall ensure compliance with all applicable laws, rules and regulations at all times.
- m. Once the Scholar has attained majority and has found gainful employment, the Scholar shall exercise his/her best efforts to sponsor a future scholar as part of the SDF charitable program.
- n. On completion of the course as set out in Annexure 1, if SDF at its sole discretion provides the Scholar with a renewed scholarship to pursue higher studies or an undergraduate degree as may be applicable, then SDF shall notify the Scholar of the revised terms in relation to the renewed

scholarship. Notwithstanding clause 5(c) of this Agreement, the Scholar acknowledges and agrees that any such notification shall amend and replace Annexure 1. Should the Scholarship continue upon the Scholar attaining eighteen (18) years of age, the Scholar undertakes to accept the electronic terms as made available by SDF.

### 3. Limitation of Liability and Waiver of Claims

- a. In no event shall SDF be liable, whether in contract, tort (including negligence) or otherwise for special, direct, indirect, incidental, punitive or consequential damages of any nature whatsoever or howsoever arising out of this Agreement. In the event these limits aforesaid are held to be unenforceable under law, SDF's total aggregate liability under or in relation to this Agreement, howsoever arising, shall be limited to Rupees One Hundred only (INR 100/-).
- b. The Scholar acknowledges and understands that SDF is a charitable foundation and the Scholarship offered is a part of its charitable program. Neither SDF nor the Sponsor shall be under any continuing obligation to make payments to the Scholar and may at any time in its discretion stop making payments to the Scholar. In light of the above, the Scholar hereby specifically waives any claims that they may now have (either now or in the future) against SDF in relation to this Agreement. The Scholar hereby releases SDF from any liability for any loss, injury, damage or expense the Scholar may suffer as a result of the Scholar's participation in the scholarship program.

### 4. Term and Termination

- a. This Agreement shall come into force on the Effective Date and continue until the Scholar completes his higher secondary education, subject to the terms of this Agreement. SDF may terminate this Agreement and the Scholarship grant if the Scholar commits a material breach of this Agreement without the need for any notice or SDF may terminate this Agreement for its convenience upon thirty (30) days' notice.

### 5. Miscellaneous


- a. This Agreement shall be construed, interpreted and governed by the laws of India and all disputes arising out of or relating to this Agreement shall be subject to the exclusive jurisdiction of the competent courts in Bangalore, Karnataka.
- b. No waiver of any provision of this Agreement shall be effective unless it is in writing and signed by the party against which it is sought to be enforced. The delay or failure by either party to exercise or enforce any of its rights under this Agreement shall not constitute or be deemed a waiver of that party's right.
- c. This Agreement shall constitute the entire Agreement between the parties hereto and supersede all previous agreements on the subject matter hereto. Any and all amendments to this Agreement shall only be effective if it is in writing, executed by both parties.
- d. The Scholar shall not assign this Agreement to any third party.
- e. If a court of competent jurisdiction finds any part of this Agreement invalid or unenforceable, the remainder of this Agreement shall be interpreted so as to reasonably affect the intention of the parties.
